CLINICAL LAW STUDENT

- Part-time; ~17 hours per week
- Class credit (4 units)
- 204-hour commitment; 130 minutes of in-person class work, and an additional 15 hours per week outside of class
- Weekly team meetings are mandatory
- Flexible schedule; at least one full weekday reserved for travel for investigation and court hearings

ORGANIZATIONAL SUMMARY:

California Innocence Advocates (Cal-IA) fights to free the wrongfully convicted and provide support to those re-entering society after decades behind bars. We are a team of innocence lawyers, legal fellows, law clerks, formerly incarcerated people, criminal-legal policy experts, people directly impacted by the system, and volunteers. Together, we have decades of experience in post-conviction investigation, legal research, and litigation. Join us in our mission to liberate the innocent.

COURSE AND CLINIC DESCRIPTION

Students enrolled in the Innocence Clinic at California Western will work alongside experienced post-conviction attorneys to seek the release of wrongfully convicted prisoners in the state of California.

The summer course is comprised of a seminar and a clinical component.

The seminar will meet once a week on campus for 130 minutes. Students will receive 2 credits for the seminar portion of the course. This course will explore the issue of wrongful convictions, from causes to remedies. Students will study real cases to examine the causes of wrongful convictions. Students will then learn how post-conviction lawyers evaluate, investigate, and litigate wrongful convictions to bring decades-old cases back to court and free the

innocent. Finally, during the seminar, students will learn the anatomy of post-conviction motions and petitions, and how to persuasively draft these important pleadings.

Students will receive two additional credits for case work performed under the supervision of their assigned attorney. Students will be required to spend a minimum of 15 hours per week outside of the class session on assigned readings and casework. During the clinical portion of this course, law students will work alongside their supervising attorneys and private investigators to evaluate claims of innocence, investigate these claims, research the law pertaining to the cases, draft legal documents including motions, witness declarations, briefs, legal memoranda, petitions, letters to attorneys and clients, expert reports, and case round memos. Students also attend and participate in court proceedings and advocate for clients.

To receive the most fulfilling experience, students should be prepared to travel for investigations and court hearings throughout Southern California, from Kern County down to the Mexico border. To that end, it is suggested that students keep at least one full weekday completely available for this case work.

There is no final exam. Students are graded on the written work they produce in the course and on their closing memo and presentations.

Sequence & Prerequisites: No prerequisites, but enrollment is strictly limited to 14 students.

In order to represent clients in court, law students must have already taken Civil Procedure and concurrently enrolled in Evidence. Students must also have completed the paperwork to be certified by the State Bar of California to represent clients. Obtain a certification form from the Registrar's Office or at www.calbar.org.

DUTIES

Intake:

 Under the supervision of the Clinic staff, interns will complete intakes and evaluate incarcerated people's claims of actual innocence.

• Legal Services:

- Review and accurately synthesize the factual background of cases, including police reports, lab reports, trial transcripts, prior motions and case files.
- Write memos concerning discrete fact-based questions.
 For example, regarding whether case facts from the complete record support a particular exoneration theory; prior and current testing history; evidence searches; post-conviction investigation issues.
- Draft various other materials in support of litigation strategy, for example cover letters and press statements.
- Prepare court documents for filing, inclusive of proofreading briefs, reviewing citation format in briefs for completeness in accordance with California Manual (yellow book); copying, collating, binding documents and exhibits, preparing tables of contents and tables of authorities, reviewing and summarizing court rules.
- Conduct legal research using online databases such as Westlaw or Lexis Nexis.
- Assist with evidence searches, discovery requests and responses, and with preparing public records requests.
- Liaise with forensic laboratories, and other experts; prisons.
- o Communicate with incarcerated clients and/or their family members.
- Maintain up-to-date and well-organized electronic and paper case files and docket sheets.
- Under the supervision of Clinic licensed attorneys, work on all phases of litigation. Legal services may include any, or a combination of the following: legal research and writing; client intake and case evaluation; discovery and case investigation, which may include records requests, document review, and drafting written discovery requests; legal document

drafting, such as petitions, motions, and responses; client representation, and other practical litigation skills; communication with clients, experts, service providers, and opposing counsel; participate in general office and case management upkeep duties, including, but not limited computer data entry of intake and other case information, filing, copying, drafting and filing court documents, and serving notice.






APPLICATION QUESTIONS



My signature also constitutes that I will not retain, copy, use, disclose, or disseminate any client information or materials, or any information or materials from Cal-IA for any purpose not associated with this internship.
